Fayette County 4-H Camp scholarships will be awarded based on financial need of the family and participation of the 4-H'er in 4-H activities. Preference will be given to those who have not received a camp scholarship in the past. The Fayette County 4-H Program funds are limited. Funds that are available for scholarships have been donated by local businesses, organizations and individuals. Therefore, it is important to make every effort to distribute those funds as fairly as possible. We hope that this form will help the committee make more informed decisions and allow us to award scholarships to those with the greatest need and most enthusiasm for the 4-H program.

Decisions pertaining to scholarship awards will be made by an independent committee. Decisions will not be made until late May or early June. You will be contacted after this date concerning the status of your application. (NOTE: Applicants without a phone number or email address listed below should contact the Fayette County 4-H Office after the above date to inquire about application status.) **If a child receives a partial scholarship, the remaining balance of the camp fee for Jr. & Jr. High Camp will be due in full on June 7<sup>th</sup>. (Deadline may be extended.)**
